#### **Policy Statement**

This returns and refunds policy is in accordance with the EU Distance Selling Directive which came into force in October 2000 and is part of UK law under the Consumer Protection (Distance Selling) Regulations 2000. ### Your rights as a consumer

## How to cancel within the 7 day cooling off period

#### Returns and refunds outside the 7 day cooling off period

# Refunds for unwanted goods

Providing that unwanted goods are received by us in unused, unopened and resaleable condition within 7 days of delivery, we will refund payment for the goods. Orders placed by credit or debit card from this website will be refunded directly to your credit or debit card. Orders placed by other means will be refunded by bank transfer. These refunds will be made within 30 days of return of goods.
